

COMPANY POLICY DOLOMITE FRANCHI

Dolomite Franchi, a company of the Intocast AG Group, has been producing dolomite refractories for lining electric furnaces, ladles, AOD converters and the like used in the steel industry since 1919. The product range is based on dolomite extracted from its own quarry and includes sintered dolomite, sinterdolomite masses, tempered dolomite bricks with carbon-based binders.

Dolomite Franchi's geographical location is particularly favourable for rapidly shipping finished products to Italian, European and overseas steel mills by truck, combined road and rail, and by sea in containers.

The basic principle of the company policy of Dolomite Franchi S.p.A. is to achieve the highest quality of all company processes and products, adopting all the measures necessary to ensure that work activities are carried out efficiently, reliably and in accordance with the needs of customers, in terms of quality, service, safety, respect for the environment, efficient use of energy resources and t h e requirements of current legislation. For this reason, responsible behaviour in relations with our collaborators is a categorical imperative achieved through the promotion of a process of self-responsibility on the part of individual collaborators.

Dolomite Franchi S.p.A. is aware that it is part of a world that must learn to respect

This is why it considers it fundamental to pay attention to environmental protection policies, technological innovation oriented towards saving non-renewable natural resources.  - The prevention of occupational accidents and diseases and the prevention of pollution environmental;
 - Reducing the effects of environmental impact through investments in production, to an extent that is economically viable for the company;

- The reduction of waste products and waste of natural resources, the efficient use of energy and the focus on the recovery of residual substances through re-circulation or reuse of materials;

 - ✓ optimisation of resources in order to constantly monitor its environmental and social impacts, in compliance with current legislation and the expectations of all stakeholders.
