Dolomite Franchi, a company of the Intocast AG Group, has been producing dolomite refractories since 1919 for the coating of electric furnaces, ladles, AOD converters and the like used in the iron and steel industry. The product range is based on the dolomite extracted from its own quarry and includes sintered dolomite, sintered dolomite masses, dolomite bricks tempered with carbon-based binders.

Dolomite Franchi's geographic location of is particularly favorable for quickly shipping finished products to Italian, European and overseas steelworks by means of transport by truck, combined rubber and rail, and by sea in containers.
